## तालिबानी नेता को प्रतिबंधित सूची में डालने की मांग

काबुल। वार्ता। अफगानिस्तान के राष्ट्रपति अशरफ गनी ने संयुक्त राष्ट्र की प्रतिबंधित समिति से तालिबान के नए नेता मुल्ला हैबतुल्ला का नाम प्रतिबंधित सूची में शामिल करने की मांग की है। उन्होंने काबुल में संयुक्त राष्ट्र प्रतिबंधित समिति के सदस्यों के साथ अपनी बैठक में मुल्ला हैबतुल्ला सहित अन्य तालिबान आतंकवादियों का नाम भी प्रतिबंधित सूची में शामिल करने की मांग की है।

मुल्ला हैबतुल्ला को तालिबान प्रमुख मुल्ला अख्तर मंसूर के अमेरिकी ड्रोन हमले में मारे जाने के बाद तालिबान का नया प्रमुख बनाया गया था। अफगानिस्तान की शांति प्रक्रिया को आगे बढ़ाने के लिए तालिबान अपने सदस्यों का नाम संयुक्त राष्ट्र की प्रतिबंधित सूची से हटाने की मांग करता रहा है किंतु अब उनके प्रमुख का नाम इस सूची में शामिल करने से शांति प्रक्रिया के मार्ग में और बाधा पैदा होगी।

## रूस में रिश्वतखोरी में आर्थिक मंत्री गिरफ्तार

मॉस्को। एफपी। रूस में सरकार नियंत्रित तेल कंपनी रोसनेफ्ट से जुड़े एक बड़े सौदे में 20 लाख डॉलर की रिश्वत लेने के संदेह में वित्त मंत्री एलेक्सेई उलयुकायेव को हिरासत में लिया गया है।

जांच समिति ने एक बयान में कहा कि उलयुकायेव को एफएसबी सुरक्षा सेवा के जरिए चलाए गए अभियान के परिणामस्वरूप हिरासत में लिया गया। इसने दावा किया कि मंत्री ने 5.2 अरब डॉलर के सौदे में रूसी तेल कंपनी बाशनेफ्ट में रोसनेफ्ट को राज्य से एक बड़ी हिस्सेदारी हासिल करने की इजाजत देने के लिए रिश्वत ली।
